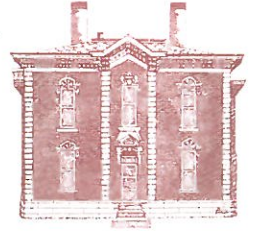

## **THE MINUTES**

**April 21, 2016**

The Holmes County Commissioners met in regular session Thursday, April 21, 2016; with everyone present. Chairman Eyler opened the meeting:

### **8:30 A.M. – CHRIS YOUNG – ENGINEER – STANDING APPOINTMENT - CANCELLED**

### **9:30 A.M. – CDBG 1<sup>ST</sup> PUBLIC HEARING – FY'2016 – COMMISSIONERS MEETING ROOM**

Clerk Susan Haun opened the CDBG 1<sup>st</sup> Public Hearing for FY'2016 in the Commissioners Meeting Room. Oliver gave the background of CDBG. Those in attendance to the hearing are as follows – Arnie Oliver, Director of the Holmes County Planning Commission, Tracy Schlabach of the Planning Commission and Clerk Susan Haun.

Oliver stated that we have \$91,000.00 for CDBG Funding for this year, \$73,600.00 will be for projects and engineering. Oliver next gave the history of the CDBG Projects over the years.

Schlabach discussed and explained Fair Housing.

Applications that Oliver has received for the CDBG FY'2016:

Holmes County Home – Re-do structural foundation of restroom facilities - \$65,000.00

Lake Memorial Park – Richland Township – Chip and seal parking lot - \$10,250.00

Village of Millersburg – South Mad Anthony streetscape and sidewalk project – cost to be determined

The Commissioners will decide which project(s) and announce them at the 2<sup>nd</sup> CDBG FY'2016 Public Hearing on May 30, 2016 at 9:30 a.m. in the meeting room of the Holmes County Commissioners.

### **9:45 A.M. – COMMUNITY DEVELOPMENT IMPLEMENTATION STRATEGY – PUBLIC HEARING – COMMISSIONERS MEETING ROOM**

In 2015 the State changed the requirements for the Community Development Implementation Strategy. Last year's changes are still valid and Oliver is checking with the State to see if the Community Development Implementation Strategy need to be updated to include the current 2016 projects.
