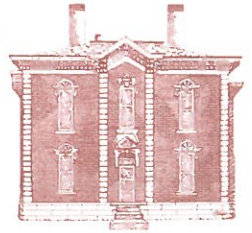

THE MINUTES
February 16, 2017

The Holmes County Commissioners met in regular session Thursday, February 16, 2017; with Mr. Miller absent. Vice-Chairman Ault opened the meeting:

9:30 A.M. – SHERIFF TIM ZIMMERLY – UNDER SPEED, UTILITY VEHICLES AND MINI TRUCKS DISCUSSION

Sheriff Tim Zimmerly, Prosecutor Sean Warner and Judge Andy Hyde met with the Commissioners to discuss the operation of under-speed or utility vehicles or mini-trucks on a public street or highway under its jurisdiction. This was passed the beginning of 2017. It's for County and Township Roads that are 35 m.p.h. or less and does not include state routes and the vehicles are 900 to 2,200 lbs. Only includes three vehicles a mini truck, a under speed vehicle (golf cart) and utility vehicle. Warner believes that this would be more for the villages in Holmes County; we have no County or Township roads with 35 m.p.h. speed limits. The Sheriff's Office has to inspect these vehicles. Once the County passes the resolution, these vehicles will need insurance also to be on the roads. Also if this is passed by resolution, will this eliminate the vehicles from traveling on the County and Township roads since the speed limit is 45 m.p.h. to 55 m.p.h.? The Commissioners will postpone the Resolution until everything can be looked into further.

10:00 A.M. – DEB MILLER – COUNTY HOME – COUNTY HOME ROOF DISCUSSION

Deb Miller of the County Home met with the Commissioners and presented them with a quote to replace the ridge caps at the County Home. The quote Miller has is from West Holmes Roofers in the amount of \$7,900.00. Ault would like to see a couple more quotes before making any decisions. Also Miller informed the Commissioners that the roof on the barn will need replaced in the near future. Miller informed the Commissioners that Friends of Ohio Barns will be including the County Home Barn in their tour this year. Miller also has Friends of Ohio coming to look at the County Home Barn since they also do barn restorations.

With no further business to come before the Board, Mr. Eyler moved that the meeting be adjourned at 4:30 p.m.; Mr. Ault seconded the motion (Mr. Miller- absent; Mr. Ault – yes; Mr. Eyler - yes).
