John Beam Dog Warden met with the Commissioners to update them on several items.

Beam informed the Commissioners that there will be a Poker Run to raise funds on September 02, 2017

The Dog Wardens Office has also sold out of Dog Licenses for the first time. They have created a lot of new accounts this year.

Beam would also like to update their firearms policy to either match the Sheriff's Office or the Millersburg Police Departments. Beam is currently working with Prosecutor Warner on this update and also working on updating the Dog Warden's Office entire policy.

For safety and liability reasons they need to update the pit bull adoption policy. The state no longer considers pit bulls vicious or dangerous. Beam would like the Pitbull policy dismissed. The Commissioners do not have a problem with this, if Prosecutors Warner agrees that the County will not be held responsible for any injuries and it will hold up in court it is alright with them.

Finally discussed was the Tractor Supply (TSC) Dog Adoption event that TSC would like the Dog Wardens Office to participate in. The Commissioners gave their approval for this event.
