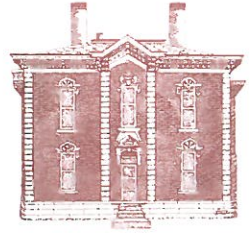

Assistant Prosecutor Warner met with the Commissioners to discuss the gravel that Kurt McDowell who currently has the County Home land lease is taking out of the creek at the County Home. Miller is worried that McDowell does not have a permit to mine the gravel out of the creek at the County Home. Warner will be looking into whether or not McDowell has a permit for the mining of the gravel with ODNR. Engineer Young will also have a gentleman from the contact Warner from the EPA too. Warner will also draft up a letter to McDowell about not cleaning out the creek and then come back in for a meeting with the Board and go over the draft letter.
