PROCLAMATION #06-16-22-1P

LOCAL EMERGENCY PROCLAMATION

Holmes County, Ohio

June 16, 2022

Authority

WHEREAS, Holmes County, Ohio has been or is immediately threatened by damage caused by a severe storm; and

THEREFORE, BE IT PROCLAIMED that we the Holmes County Board of Commissioners, declare that a state of emergency exists in the county and that we hereby invoke and declare those portions of Ohio Revised Code which are applicable to the conditions and have caused the issuance of this proclamation, to be in full force and effect in the county for exercise of all necessary emergency authority for protection of lives and property of the people of HOLMES COUNTY and the restoration of local government with a minimum of interruption.


Reference is hereby made to appropriate laws, statutes, ordinances and resolutions and particularly to Section 5502 of the Ohio Revised Code.

All public offices employees of HOLMES COUNTY are hereby directed to exercise the utmost diligence in the discharge of their duties required of them for the duration of the emergency and in execution of emergency laws, regulations and directives – state and local.

All citizens are called upon and directed to comply with necessary emergency measures, to cooperate with public officials and disaster service forces in executing emergency operations plans, and obey and comply with the lawful directions of properly identified forces.

All operating forces will direct their communications and requests for assistance directly to the Emergency Operations Center (EOC).
