Michael Derr Health Department and Misty Burns Health Department President met with the Commissioners to discuss the finances of several departments within the Health Department. The Health Department receives little or no funding for the following services: litter prevention, mosquito control (scrap tire removal), monitor the Landfill quarterly, nuisance properties, the food service side – twice a year inspections on food trucks, restaurants, bakeries, etc, help OSU Extension with safe serve classes, sewer connections only receive small admin costs, CEUS for installers class once a year, private water nuisance investigations, they also do school inspections voluntary and inspections at the County Jail are required, vector along the trail for mosquitos ticks and in Killbuck, animal bites, personnel health for the older generation, nursing area have cut outreach programs In half, TB control, expand the vaccine to older adults. No decisions were made at this time. Derr entertained questions from the press.
